Membership Terms and Conditions

Wythall Community Club ('The Club') Members are entitled to use all parts of Wythall Park, subject to the constitution of Wythall Community Association ('The Association') and The Club rules.

Applications should be made on behalf of all members of a family who may wish to use the facilities, which are provided exclusively by The Association or The Club.

Under 18's are eligible for free (Junior) membership of The Association, but cannot become members of The Club until they reach 18 years of age. They are allowed to enter The Club providing that they are supervised by an appropriate Adult Club member. When a Junior member reaches 18 years of age, they will be able to upgrade their membership to allow them to participate fully in Club life.

Membership of The Club is open to application by all paid-up members of the Association aged 18 years and over. Accepted applications entitle Members to use the licensed facilities of the Registered Members' Club within The Club Rules.

Membership applications are processed monthly at the next Club Committee meeting, typically the last Wednesday each month.

Your information is protected under the Data Protection Act 2018.

Your email address will be used solely by The Association and / or The Club to advise you from time to time of future events, membership renewals and other such news pertinent to The Association and / or The Club. It will never be sold or shared with any third parties in accordance with our Privacy Policy.

For new applications, your name may be published in the entrance hall of The Club for a period of 3 days following application

All new applications require a Proposer and Seconder, both of whom must be current paid up members of The Club. If you do not have a proposer and seconder, please contact us.

In the event that a membership is declined for any reason, the membership fee paid at the time of the application will be refunded in full.

Gift Aid

Your donation could be worth even more to Wythall Community Association through the Gift Aid scheme. Signing the Gift Aid box on the application form means we can reclaim tax for every £1 you give. To qualify you must pay an amount of income tax and / or capital gains tax at least equal to the tax that the charity reclaims on your donations in the tax year.

Funds raised will go towards the charitable and public benefits of Wythall Community Association.

We will share required details, such as your name, first line of address and postcode with HMRC as required to claim the Gift Aid. If you pay Income Tax at the higher or additional rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your Self-Assessment tax return or ask HM Revenue and Customs to adjust your tax code.

Events, Entertainment and Online Bookings

The Club will provide events and entertainment from time to time. These events will be advertised on the Club and Association websites, their events calendars, weekly email newsletters and appropriate social media (Facebook / Instagram / TikTok etc).

Instruction will be provided regarding the booking of events either online, from the bar or both.

Payments will be processed securely online through our chosen payment gateway. You do not need an account and you will be given the option to pay by credit or debit card.

Proof of membership of The Association and / or The Club may be required for entry to The Club, and for some events.
